

**AMENDMENT #2 TO ORDINANCE NO. 99-3
CROCKETT'S COVE AND EAST CROCKETT'S COVE
AGRICULTURAL AND FORESTAL DISTRICT ORDINANCE
OF WYTHE COUNTY, VIRGINIA**

A public hearing was held on the 9th day of May, 2017 at 7:05 p.m. in the Board Room of the Wythe County Office Building, 340 South Sixth Street, Wytheville, Virginia to consider amending Ordinance No. 99-3 entitled, "Crockett's Cove and East Crockett's Cove Agricultural and Forestal District Ordinance of Wythe County, Virginia" as follows:

Delete:

6.1 The Crockett's Cove and East Crockett's Cove Agricultural Districts are hereby renewed for a period of ten (10) years beginning on the day of March 20, 2017 and terminating on the day of March 22, 2017.

Add:

6.1 The Crockett's Cove and East Crockett's Cove Agricultural Districts are hereby renewed for a period of ten (10) years beginning on the day of May 10, 2017 and terminating on the day of May 10, 2027.

Delete:

Section 6.2 in its entirety.

Add:

6.2 The Crockett's Cove and East Crockett's Cove Districts shall consist of 4,930 acres. The districts shall be located in the East Wytheville Magisterial District and shall include the following parcels:
