Specifications

Design & Installation of Monopole Sign

Sign shall be located on the 41+/- acre tract located on southeast quadrant of Exit 77 of I-81/I-77 in Wythe County. Plat and site layout of Apex Center attached.

Sign shall incorporate the attached logo of the APEX center.

Sign shall include programmable LED message boards and shall be designed for maximum visibility from both directions of travel on the interstates.

Sign design shall include ability to install additional signs below message boards (example sponsor's names, XYZ Soccer Fields, etc)

Sign design and location shall address state and federal outdoor advertising regulations including, but not limited to, height, brightness, location from interstate, location from APEX building, LED functionality, etc.

Bids shall indicate design & construction schedule.

Bids shall be limited to no more than two proposals per company.

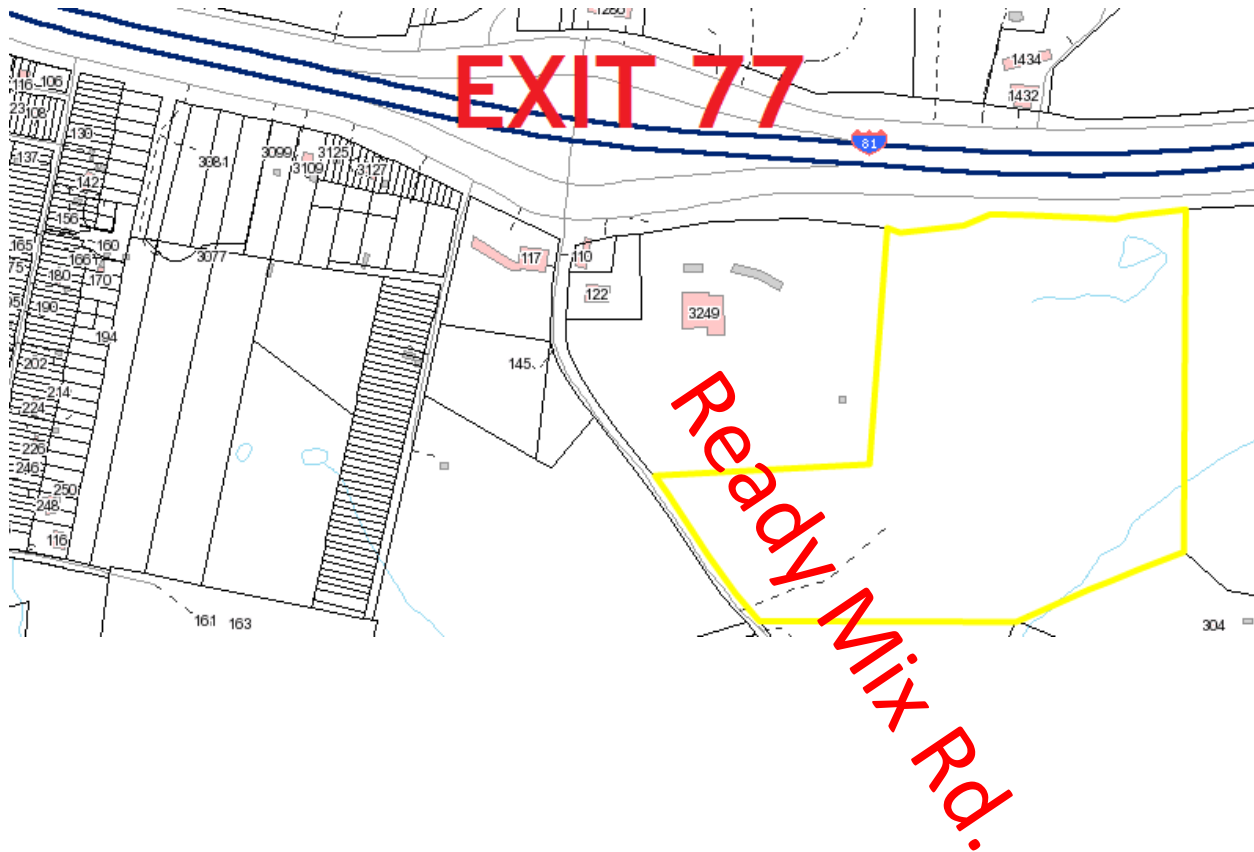
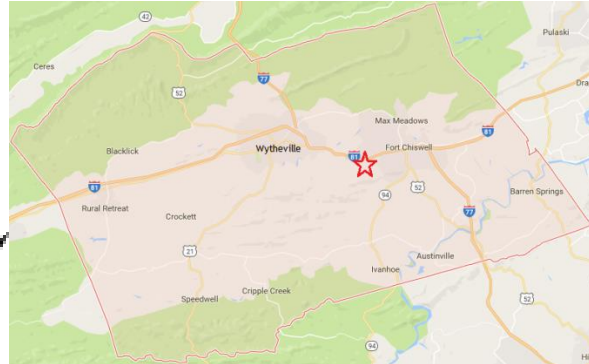
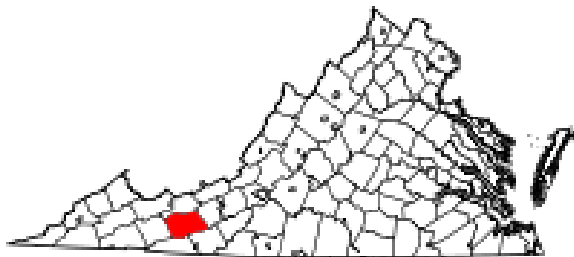
