ORDINANCE ABOLISHING THE FINANCE BOARD OF WYTHE COUNTY, VIRGINIA NO. 2005-7

A public hearing was held on August 9, 2005 at 7:10 p.m. in the Board of Supervisors Meeting Room, 340 South Sixth Street, Wytheville, Virginia 24382, to consider enacting an ordinance abolishing the Wythe County Finance Board.

ARTICLE I – Title, Authority, Jurisdiction and Purpose

- 1.1 <u>Title</u>. This ordinance shall hereinafter be known as, and may be cited as, the "Ordinance Abolishing the Finance Board of Wythe County, Virginia", Ordinance #2005-7.
- 1.2 <u>Authority</u>. This ordinance is adopted pursuant to the authority of Section 58.1-3151 of the Code of Virginia 1950, as amended.
- 1.3 <u>Jurisdiction</u>. The provisions of this ordinance shall apply to Wythe County including the incorporated municipalities.
- 1.4 <u>Purpose</u>. This ordinance is to abolish the Finance Board of Wythe County.

ARTICLE II – Abolishion of Finance Board

The Wythe County Finance Board is hereby abolished, whereupon all authority, powers, and duties of the Finance Board shall vest in the governing body.

ARTICLE III – Legal Status Provisions

<u>Certified Copies of Ordinances</u>. Certified copies of this ordinance and all amendments thereto shall be filed in the offices of the Planning Commission, the County Administrator, and the Clerk of the Circuit Court of Wythe County, Virginia.

<u>Validity</u>. Should any article, section, subsection, or provision of this ordinance be declared by a court of competent jurisdiction to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of this ordinance as a whole or any part thereof other than the part so declared to be invalid or unconstitutional.

<u>Effective Date</u>. This ordinance was duly considered following the required public hearing held on August 9, 2005, and was adopted by the Board of Supervisors of Wythe County, Virginia, at its regular meeting held on August 9, 2005, the members voting:
