

**AMENDMENT #1 TO ORDINANCE NO. 99-3
CROCKETT'S COVE AND EAST CROCKETT'S COVE
AGRICULTURAL AND FORESTAL DISTRICT ORDINANCE
OF WYTHE COUNTY, VIRGINIA**

A public hearing was held on the 19th day of March, 2007 at 9:00 a.m. in the Board Room of the Wythe County Office Building, 340 South Sixth Street, Wytheville, Virginia to consider amending Ordinance No. 99-3 entitled, "Crockett's Cove and East Crockett's Cove Agricultural and Forestal District Ordinance of Wythe County, Virginia" as follows:

Delete:

6.1 The Crockett's Cove and East Crockett's Cove Agricultural Districts are hereby established for a period of four (4) years beginning on the day of March 23, 1999, and terminating on the day of March 23, 2003.

Add:

6.1 The Crockett's Cove and East Crockett's Cove Agricultural Districts are hereby renewed for a period of ten (10) years beginning on the day of March 20, 2007 and terminating on the day of March 22, 2017.

Delete:

Section 6.2 in its entirety.

Add:

6.2 The Crockett's Cove District shall consist of 2,166 acres; and, the East Crockett's Cove District shall consist of 2,766.133 acres. The districts shall be located in the East Wytheville Magisterial District and shall include the following parcels:

Delete:

6.6 The districts shall continue in effect until they are reviewed in 2002. Said review of the districts is to be completed in accordance with Section 15.2 of the Code of Virginia, and amendments thereto.

Add:

6.6 The districts shall continue in effect until they are reviewed in accordance with Section 15.2 of the Code of Virginia or until the district terminates as cited in Section 6.1 of this ordinance.

Delete:

6.9 The landowners of the Crockett's Cove and East Crockett's Cove Districts shall prepare a conservation plan of forestry management within one year of the establishment of the Districts. Copies of this plan shall be filed with the County Extension Agent of Wythe County, the Wythe County Planning Commission, and shall comply with the forestal plan prepared by the State Forester. This plan shall be reviewed every two years and within two months of the termination date of this district. The plans shall be reviewed by the Extension Agent and Planning Commission to determine compliance with the plan as originally filed or subsequently amended.

Add:

6.9 The landowners of the Crockett's Cove and East Crockett's Cove Districts are encouraged to prepare a conservation plan of forestry management.

Add:

6.11 Landowners shall not develop land to a more intensive use other than more intensive agricultural production and forestal production per Section 15.2-4309 of the Code of Virginia.

Supervisor McDaniel made a motion to approve this amendment. The motion was seconded by Supervisor Dix and the roll call vote is as follows:
