

**JAIL PROCESSING FEE ORDINANCE
OF
WYTHE COUNTY, VIRGINIA
NO. 2002-3**

Article I – Title, Authority, Jurisdiction, Purpose

- 1.1 Title:** This ordinance shall be known as “Jail Processing Fee Ordinance of Wythe County, Virginia”, Ordinance No 2002-3.
- 1.2 Authority:** It is adopted pursuant to the Authority of Section 15.2-1613.1 of The Code of Virginia, and amendments thereto.
- 1.3 Jurisdiction:** The Provisions of this ordinance shall apply to Wythe County, Virginia including the incorporated municipalities where county facilities are located.
- 1.4 Purpose:** To provide funding for costs of processing arrested persons into local or regional jails as provided in the Code of Virginia.

Article II – Rules

- 2.1** The fee shall be twenty-five dollars (\$25.00) and shall be assessed and imposed on any individual admitted to regional jail following conviction within the county of Wythe of a crime, misdemeanor or violation or local ordinance of the county of Wythe or any town located within Wythe County.
- 2.2** This ordinance shall become effective at 12:01 AM on August 1, 2002.
- 2.3** The fee shall be collected by the Clerk of the Court with other cost. The Clerk shall remit the fees to the Treasurer of Wythe County.
- 2.4** The Treasurer of Wythe County shall set up a Dedicated Fund code so that warrants may be drawn upon this account as provided by in the Code of Virginia. The Treasurer shall apply all interest earned upon these funds into this account.

Article III

- 3.1 Restrictions:** These funds shall only be used for the purpose as provided for in the Code of Virginia and amendments thereto.

Article IV

4.1 Certified Copies of Ordinance: Certified copies of this ordinance and amendments thereto shall be filed in the Office of the County Administrator, of the General District Court, the Clerk of Circuit Court, and the Clerk of Juvenile and Domestic Court.

4.2 Effective Date: This ordinance was duly considered on July 23, 2002 and was adopted by the Board of Supervisors of Wythe County at its meeting on July 23, 2002, the member voting as follows:
