

**AMENDMENT NO. 1 TO ORDINANCE NO. 2009-3**  
**Service District for**  
**Hidden Valley Area of**  
**Wythe County, Virginia**

A public hearing was held on the 23<sup>rd</sup> day of August, 2011 at 9:05 a.m. in the Board Room of the Wythe County Administration Building, 340 South Sixth Street, Wytheville, Virginia to consider Amendment Number 1 to Ordinance #2009-3 entitled, "Service District for Hidden Valley Area of Wythe County, Virginia".

**DELETE:**

**Section 4 – Additional Tax Imposed**

To provide for additional governmental services not being offered uniformly throughout the county, there is hereby levied an initial tax of \$400 per landowner in this service district. This tax is applicable to each landowner only in the service district irrespective of the number of parcels owned. This tax will exist for a period of seven (7) years or until the actual cost as allowed in Section 3A and the total project construction cost (including relocation of utility lines) is repaid. The estimated project cost attributable to this district is \$85,370.

All procedures for and details of administration and collection of the tax imposed by this ordinance shall be the same as provided for by the Code of Virginia and the ordinances of Wythe County for real estate taxes generally. The tax levy shall be adjusted based on actual project cost and tax revenue received.

**ADD:**

**Section 4 – Additional Tax Imposed**

To provide for additional governmental services not being offered uniformly throughout the county, there is hereby levied an initial tax of \$588 per landowner in this service district. This tax is applicable to each landowner only in the service district irrespective of the number of parcels owned. This tax will exist for a period of seven (7) years or until the actual cost as allowed in Section 3A and the total project construction cost (including relocation of utility lines) is repaid. The estimated project cost attributable to this district is \$112,514.


All procedures for and details of administration and collection of the tax imposed by this ordinance shall be the same as provided for by the Code of Virginia and the ordinances of Wythe County for real estate taxes generally. The tax levy shall be adjusted based on actual project cost and tax revenue received.

At the September 13, 2011 Board of Supervisors' Meeting Supervisor Martha P. Umberger made a motion to approve this amendment. The motion was seconded by Supervisor Danny C. McDaniel and the roll call vote is as follows:
