

ORDINANCE NO. 93-2

AN ORDINANCE DISCONTINUING AND VACATING AN ALLEYWAY BETWEEN EIGHTH AND NINTH STREET AND BETWEEN CARROLL AND PARK AVENUE IN THE COMMUNITY OF IVANHOE, LEAD MINES MAGISTERIAL DISTRICT

AN ORDINANCE DISCONTINUING AND VACATING an alleyway between Eighth and Ninth Street and between Carroll and Park Avenue in the Community of Ivanhoe, Lead Mines Magisterial District, Wythe County, Virginia, Ordinance No. 93-2.

WHEREAS, property adjoining an alleyway between Eight and Ninth Street and Carroll and Park Avenue owned by Ronald E. Blair and Myra D. Blair, and the estate of Martha Ellen Blair in the Community of Ivanhoe, Lead Mines Magisterial District, Wythe County, Virginia; and

WHEREAS, it appears that no inconvenience will result to others from a discontinuance of portions of said streets and alleyways; and

WHEREAS, Section 15.1-482 of the Code of Virginia, 1950, as amended, permits the discontinuance of alleys, streets, and other public areas laid out or described in plats of records; and

WHEREAS, pursuant to the provisions of Section 15.1-431 of the Code of Virginia, 1950, as amended, notice required thereby was duly given;

NOW, THEREFORE, be it ordained that the alleyways which are darkened on that Wythe County tax map, Section 73-9 which is attached to this ordinance and is hereby made a part of this ordinance by reference; in the Community of Ivanhoe, Lead Mines Magisterial District, Wythe County, Virginia, are hereby discontinued and vacated.

BE IT FURTHER ORDAINED, that a certified copy of this ordinance be recorded as deeds are recorded and indexed in the name of the County of Wythe, Clerk's Office of the Circuit Court of Wythe County, Virginia.

This ordinance was duly considered following a required public hearing held on March 23, 1993, and was adopted by the Board of Supervisors of Wythe County, Virginia, at its regular meeting held on March 23, 1993, the members voting:
